2. CSC Subcommittee Reports

A. Construction Observation/Inspector's Course (Steve/Scott) – February 24-26, 2026 at Bowen's office in Indianapolis

B. Collection Systems Certification Exam (Jeff)

Florida Reciprocity Evaluation Summary

The Collection System Committee (CSC) was contacted by IWEA staff in December 2025 to confirm if and how reciprocity would be applied to a Collection System Class C Certification (presumed to correlate to the Level 3 Basic Course) from the Florida Water & Pollution Control Operators Association (FW&PCOA). After contacting the FW&PCOA, it was noted that the following apply to the Florida Collection System Certifications:

1. Collection System Certifications are optional in the state of Florida.
2. The course provided by the FW&PCOA involves a final exam, 100 questions in length, and they must receive a passing grade to receive the certification.
3. The only prerequisites are a high school diploma and one year of experience.

After cross-referencing the table of contents for the class that had been provided by the FW&PCOA with the ABC Testing Requirements used in Indiana's Collection System Certification exams, it was decided that the reciprocity allowed would be Class 1 in Indiana. It was also noted further that if the operator meets the Class 2 experience requirements from IWEA's Wastewater Collection System Operator Certification packet, then the CSC could allow the operator to sit for the Class 2 exam.
