Meeting convened at 10:00 a.m. with introductions. Thank you to Leighanne for hosting the meeting.

## Approval of the Minutes:

Lloyd asked if there were any revisions to the minutes from the meeting on December 3, 2015. No corrections or modifications were suggested. Duane made a motion for approval of the minutes and Pam seconded the motion. The minutes were approved as written.

#### **Old Business:**

Introduction of new committee leadership team for 2016

Lloyd introduced the new committee leadership team for 2016. Lloyd is the Chair of the committee, Tamara is the Vice Chair, and Cheryl is the Secretary.

## WITtec 2016 Planning

IDEM will hold a Net DMR workshop from 9-12 on April 13, 2016. Lloyd indicated that currently 102 people have registered and he encouraged registration as soon as possible. The group discussed the Pretreatment Seminar provided by Curt McCormick and his restriction to municipal employees only and decided that Mr. McCormick could make the decision about inclusion in the seminar. Lloyd explained that Martha Martin has the CEU packet ready for submittal to IDEM.

## **New Business:**

## Topics for IWEA Annual conference

The IWEA annual conference has been moved from November to August17-19, 2016. The group brainstormed for ideas for the pretreatment sessions. Ideas included a brewery presentation including a brewery and unusual sampling situations including batch discharges. Lloyd will be sending a survey to request identification of a strength of your program and a weakness of your program to help identify other topics. Also, Lloyd encouraged having operators speak about their experiences to help other operators.

## Update on Indiana's Interference Definition

IDEM has a modification to the State definition of "Interference" to the Federal definition on Public Notice. Comments are due to IDEM by February 12, 2016.

## Volunteers for WITtec

Lloyd requested help at WITtec on Tuesday (April 12) and Wednesday (April 13). Pam and Teresa volunteered to help with registration from 7 am to 8 am. Cheryl and Larry volunteered to stamp during the sessions. Tamara will introduce Curt McCormick. Lloyd will moderate the Wednesday morning sessions and Duane will moderate the Wednesday afternoon sessions. Leighanne will collect lunch tickets on Tuesday and Pam and Mark will collect lunch tickets on Wednesday.

# **Pretreatment Dilemmas:**

Dave mentioned working with a city to help inspect an industry and provide guidance on what they should do concerning an oily sheen that was suspected to be coming from the facility. There was a brief discussion on legal authority and what the city was able to do.

Duane discussed a metal finisher that no longer used a tank and how best to document it. The company remains a categorical source and is keeping the permit. The group discussed various options including plugging or disconnecting the tank and/or reporting zero discharge.

# Topic – Quaternary ammonia products & WET:

Leighanne provided a summary of quaternary products. 'Quats' are found in various disinfection and antibacterial products used in many locations including hospitals, nursing homes, salons, food processing and preparation facilities, wood preservation industry, etc.

'Quats' are officially a pesticide and Leighanne found 17 active compounds registered with the Indiana State Chemists' Office in 525 products. It's also found in personal care products, fabric softeners, and shampoo. However, it only needs to be registered as a pesticide if there is a claim that it kills pests. EPA has information about the 'quats' under pesticides including the Aquatic Life Ambient Water Quality Criteria.

In Richmond, a transportation cleaning (categorical) company was using 'quats' as a cleaner. Due to the toxicity of the compound, they were watchful. Monitoring and testing can be used with a HACH kit which detects at .5 ppm to 5 ppm; however, the aquatic toxicity is in the ppb range.

If additional testing is needed, the State Chemist's Office can analyze; however, an active investigation of a suspected problem would be needed to enlist their assistance.

Leighanne's message was to be cognizant of 'quats' during inspections and keep it in mind if problems are noticed at the plant. If you would like a copy of her presentation, please let her know.
