### **Approval of the Minutes:**

# **Old Business:**

#### Updates for WITtec 2016

WITtec will be April 12-13, 2016, in Indianapolis. Lloyd reviewed the current information about the conference, number of participants, and schedule (available at <a href="www.iioa.net">www.iioa.net</a>).

A total of 15 exhibitors have registered; 30 speakers have been confirmed; 28 participants have registered for the Pretreatment training by Curt McCormick on Tuesday, April 12, 2016. Since she was instrumental in obtaining him, Tamara has agreed to introduce Mr. McCormick.

# <u>Topics for IWEA Annual conference</u>

- Procedures SOPs for various functions/activities

- Planning and coordination with City planning staff for new industries

Duane suggested that Keith Hicks from Gripp has a flow metering presentation that may be helpful for the participants.

#### **RPC/CPC Class**

Shaun asked about the possibility of a RPC class. Lloyd talked with Julia at IWEA and she indicated that a room should be available to hold the class. The group discussed the logistics and thought that
